No outside alcoholic beverages are allowed in the premises. No space will be sold or transferred by the original table holder without approval from the show manager.

The show manager reserves the right to refuse space rental to anyone and may discharge anyone from the show if management feels it is in the best interest of the show, other exhibitors and/or the public.

If the show gets cancelled, full refunds will be issued. IF you leave before the designated time - you could forfeit your spot in the next years show. Please be respectful of customers and other vendors and stay in the building until 2:30pm on Sunday of the show.

Roemin' Buffalo Promotions: Colby Gun & Coin Show Rules:

I. GENERAL: 1. All transactions involving the display, purchase, sale, or trade of firearms and other items at the show must comply with all applicable Federal, State and local laws. Consult the ATF/BATF regulations for details on the display/sale of modern firearms, curio and relic firearm sales and sales/purchases to/from persons that are not residents of Kansas and out of state vendors. ATF Information 5300.23A Revised October 2016

2. Tables: (a) Tables may not be moved or relocated without written permission. Nothing shall protrude past a table's edge into the aisle. (b) Space behind tables shall be maintained so that other exhibitors will have safe access to their tables and egress. (c) Tables may not be transferred between exhibitors without specific written permission of the show manager. (d) Tables not occupied by 8:00 a.m. Saturday of the Show will be forfeit without reimbursement. (e) Tables vacated prior to the conclusion of the show will revert to the show manager. (f) ALL EXHIBIT & TRADE TABLES WILL BE UNCOVERED AND MAINTAINED DURING PUBLIC SHOW HOURS. Table covers are mandatory on all tables and the use of the United States flag as a table cover is not permitted.

3. Tables shall not be left unattended or unsecured during the show.

4. Release sales slips will be given to members of the public for all items acquired from table holders.

5. Smoking is permitted in designated areas only and alcohol is not allowed in the facility.

6. EXHIBITOR BADGES: The exhibitor is responsible for all badges, tables and displays in his/her name.

7. THERE WILL BE NO REFUNDS FOR CANCELLATIONS RECEIVED AFTER March 1, 2025, unless the show is cancelled.

8. Should any problem occur; it must be immediately reported to the show manager.

9. ALL GUNS MUST BE UNLOADED AND TIED INOPERABLE. You must be sure each gun is unloaded and tied: A. Before it is placed on your table. B. Before allowing anyone to handle it. C. When any gun is handed to you or returned to your table. D. All cartridge firearms must be tied; this includes those in locked display cases. E. All detachable magazines must be removed from semiautomatic weapons. F. The show manager will strictly enforce safety rules and the decisions of the show manager are final! G. Firearms may not be worn except by uniformed law enforcement officers.

II. PERMITTED ITEMS: To maintain the show's high standards, all the items on trade tables should BE CONSIDERED COLLECTABLE, although some modern firearms may be allowed as determined by the show manager, which has the final say on permitted and prohibited items.

1. Collectable & modern small arms which comply with all Federal, State, and local laws.

2. Collectable & modern ammunition for small arms when safely presented. Ammunition must be in sealed boxes or containers.

3. Collectable & modern accessories and attachments for small arms, including sighting, carrying and cleaning equipment, supplies and accessory belts of antique nature.

4. Parts for antique arms, including material for making such parts.

5. Antique edged weapons, armor, bows, crossbows, arrows and other antique weapons.

6. Books and literature related to all allowed materials.

7. Uniforms, flags, and parts thereof, providing they comprise less than 50% (fifty percent) of the total exhibit.

8. Western Art which is defined as authentic, original art of Western American subject matter, both sculpture and graphic art. Also permitted are 19th century prints by Bodman, Catlin, etc. and 19th century collector's photographs (such as E.S. Curtis and W.H. Jackson).

9. Original authentic Native North American Artifacts. These include collectable weapons, accoutrements, beadwork, leatherwork textiles, baskets, pottery, jewelry, trade goods, etc., but NOT IMPORTED jewelry or artifacts.

10. Collectable Western Frontier Paraphernalia, such as original, authentic weapons, accoutrements, paraphernalia made for the use on the western frontier, and general western style antiques.

11. Each vendor is ultimately responsible for their own health and safety. Vendor agrees that Roemin' Buffalo Promotions has no liability for any issues, health, theft or otherwise, that arise during or after the show.

III. PROHIBITED ITEMS: 1. Fully automatic weapons, silencers, any other Title II weapons. Bulk black powder, bombs, grenades, etc. and loose ammunition are specifically not allowed.

2. Any publication or video which shows how to violate the law is prohibited, including but not limited to, booby traps, bombs, or terrorist activity (unless related to safety and prevention of such).

3. Any items determined by the show manager to not be in the best interests of the show, the show manager reserves the right to remove any item(s) deemed objectionable. Refusal to comply may result in expulsion.
